The City Recorder will administer the oath of office to Planning Commission Members Seth Barrus, **Christopher Howden, and Mino Morgese.**

2. UNSCHEDULED PUBLIC APPEARANCES

Time has been set aside for the public to express their ideas, concerns, and comments. (Please limit comments to three minutes per person. Please state your name and address.)

3. PUBLIC HEARING: REZONE APPROVAL FOR 4.12 ACRES FROM R-1-40 TO R-1-30 ZONE (Z-20-01) *Administrative*

The Planning Commission will hold a public hearing to consider a request by King Hang Yu for rezoning of 4.12 acres from R-1-40 to R-1-30 property located approximately at 4697 W 11200 N. The Planning Commission will take appropriate action.

Recommended DENIAL – Planning Commission decided that there was no compelling reason to rezone, and therefore recommended denial of the rezone to the City Council. Voted 7:0.

Next Step: City Council will review the request on January 5, 2021.

4. PUBLIC HEARING: PRELIMINARY PLAT APPROVAL FOR 35-LOT SUBDIVISION TO BE KNOWN AS BEACON HILLS PLAT E PHASES 1&2 (PP-20-06) *Administrative*

The Planning Commission will hold a public hearing to consider a request by Perry Homes for a Preliminary Plat approval for Beacon Hills Plat E Phases 1&2, a proposed 35 lot single family subdivision located approximately at 12150 North Beacon Hill Blvd. The Planning Commission will take appropriate action.

Recommended APPROVAL – Resident concerns involved increased traffic and the elevation change on the south side of the plat. The Planning Commission recommend approval of the preliminary plat as it is an administrative process. *Voted 7:0.*

Next Step: City Council will review the request on January 5, 2021.

5. PUBLIC HEARING/ORDINANCE: AMEND MULTIPLE SECTIONS OF THE DEVELOPMENT CODE RELATING TO DEVELOPMENT REVIEW PROCESS (TA-20-18) Legislative

The Planning Commission will hold a public hearing to consider a request by Highland City Staff to amend multiple sections of the Highland City Development Code relating to the development review process including subdivisions. The Planning Commission will take appropriate action.

Recommended APPROVAL – No resident comment during the public hearing. The commission liked the clarification of the subdivision process. *Voted 7:0.*

Next Step: City Council will review the request on January 5, 2021 – public hearing.

6. PUBLIC HEARING/ORDINANCE: AMEND MULTIPLE SECTIONS OF THE DEVELOPMENT CODE RELATING TO CONDITIONAL USE PERMITS (TA-20-19) Legislative

The Planning Commission will hold a public hearing to consider a request by Highland City Staff to amend multiple sections of the Highland City Development Code relating to Conditional Use Permits in residential zones. The Planning Commission will take appropriate action.

Recommended APPROVAL – No resident comment during the public hearing. The Commission decided to recommend approval with the stipulation that a courtesy notice be sent to affected residents. *Voted 7:0.*

Next Step: City Council will review the request on January 5, 2021 – public hearing.
