MAYOR'S CORNER

There are a few subjects I would like to mention this month. First, I spent time on a shift with our Fire Department this past month – Wow! We have an outstanding Public Safety District. The day was quiet for about a half hour. Then intense cardiac arrest training began. For the next 4 hours I witnessed the best training I have witnessed. Classroom instruction went over concepts, times, dosages, etc: then practical practice under observation, followed by critique, and what can we do better. Training was interrupted by an emergency call. Paramedics responded to a pool drowning. Rapid first aid, followed by expert monitoring and procedures on the trip to the hospital saved a child –wow! This was all in a days work for our excellent firefighters and paramedics. Thank you, we appreciate you and what you do.

You have received notice of fireworks restrictions. With the dry year again we must prevent dangerous fires like the Quail Fire last year. There is a map on the City website showing areas where fireworks are restricted. The areas restricted are close to heavily forested and brush areas, or are areas where firefighting is difficult to access by the fire department. Please follow the restrictions so we do not have homes or other areas in danger.

A water restriction letter was also sent to all homes. Water is in short supply this year and conservation is absolutely necessary. This requires many of us to adjust our timers and watch our consumption closer that we have in past years. There are provisions for new lawns or large acreage areas that may need to change schedules. Please read the Proclamation on the City Website for the process to request a changed schedule. By con-

serving we will have water this year and possibly next year should we have another light snowfall in the mountains. Thank you in advance for your help.

Finally, I mentioned last month we have a road transportation fee of \$15.42 per household effective July 1, 2013. The Council passed the road fee on June 18, 2013. You have received a letter explaining the need for the fee. If we delay roads now we will incur significantly higher costs later. Some have proposed using reserves now to cover the roads. We currently have a negative (-) \$500K in our road fund that must be eliminated with reserve money. Also, we cannot rob other funds reserves to use on one-time road maintenance or rebuilds. What do we do in the future in the other funds when we have a sewer line break or other high dollar capital need? Reserves in funds are just that, reserved for that fund improvements not to use on other fund improvements. Some say we should not raise any fee or tax. Interesting when asked they have no solution except the one I heard recently – wait 9 years for the bonds to be paid out then do roads. As mentioned earlier, the roads need to be done now and the costs will be higher. If the majority of citizens want that, we can do that. We do not believe that it is wise and prudent to wait and incur these higher costs.

Fireworks Restrictions

If you live in the county, or on unincorporated private lands, fireworks are banned due to the extreme dry conditions. Also, fireworks restrictions are in force for Highland City. Please visit www.highlandcity.org to view the list of restricted areas in Highland *before* setting off fireworks. During July fireworks may be discharged between the hours of 11:00 a.m. - 11:00 p.m., July 1 - July 7 and July 21 - July 27. Any party responsible for fires caused from fireworks will be responsible for cost to cover the fire.

Water Conservation Notice

On Tuesday, June 18, 2013, the Mayor and City Council passed a Water Conservation Proclamation in response to the low runoff coming out of American Fork Canyon and 70% water reduction by one of our main water sources (Deer Creek Storage Water). What does this mean to you?

- Mandatory limits on Watering Days according to the following schedule:
 - ⇒ Even Numbered Street Address: Monday, Wednesday, and Friday
 - ⇒ Odd Numbered Street Address: Tuesday, Thursday, and Saturday
 - ⇒ No Sunday Watering
- Limit of Hours: Not yet mandatory, but recommended watering between the hours of 10:00 pm—6:00 am.
- Limits of Watering Duration: Not yet mandatory, but recommended not longer than 30 minutes per station.
- Manage Runoff: Adjust sprinklers to water lawns, flowers, and gardens. Avoid excessive flow and runoff onto sidewalks and streets.
- There are penalties in place for non-compliance (see Proclamation).
- Applies to all residents in Highland.

Splash Pad Open

The Highland Town Center Splash Pad is open Memorial Day through Labor Day each year. The splash pad is open Monday through Saturday from 10:00 a.m. to dusk (weather permitting). The splash pad will not be open when temperatures are below 75 degrees, when high winds are present, and when thunderstorms or rain is present.

There is no cost to use the splash pad; however, please observe the following:

- No lifeguard is on duty
- Children under 14 years of age must have adult supervision
- No running is allowed on the splash pad or in stream
- Swim diapers and plastic diaper covers are required for children who are not potty trained
- No alcohol, smoking, glass, diving, skateboarding, bikes, or throwing debris in stream
- No pets allowed in the park or water areas
- No climbing on waterfall rocks or playing in waterfall area

Reservations for private parties are not available. Lost and Found items may be claimed at the Highland City Library. Items will be kept for two weeks before they are discarded. Go on-line to the Parks page at www.highlandcity.org for more information and hours.

Prescription Medication Drop Box at LPPD

The Lone Peak Police Department invites you to utilize our new drop box for your expired or unwanted prescription medications. The drop box is located in the lobby of the police station at 5400 West Civic Center Drive, Suite 3, Highland.

Unused medications in homes create a public health and safety concern, because they are highly susceptible to accidental ingestion, diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high--more Americans currently abuse prescription drugs than the number of those using cocaine, hallucinogens, and heroin *combined*, according to the most recent National Survey on Drug Use and Health. The majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet.

We encourage you to take an inventory of your home medicine cabinet and take advantage of this valuable service.

Residential Solicitation

Warmer weather brings door-to-door solicitors out. Highland City has strict regulations governing solicitors. All residents are urged to exercise caution with solicitors who may be canvassing the city. *Each solicitor should wear a City-issued ID badge. Ask to see it. Some solicitors only display their company or corporate badge. This is not a City licensed badge.* If a City badge is not shown, the Police Department recommends you decline business and call (801) 756-9800. To prohibit door-to-door sales at your residence, post a "No Soliciting" sign at the door.
